3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Pima County Sullivan Jackson Employment Center in concert with Compass Affordable Housing Inc., and The Salvation Army seeks Continuum of Care Program renewal funds to assure continued placement of program participants into permanent housing. CASA will utilize a Housing First approach in which housing is offered to people experiencing homelessness without preconditions (such as sobriety, mental health treatment, or a minimum income threshold) or service participation requirements and in which rapid placement and stabilization in permanent housing are primary goals. The Written Standards establishes that all Permanent Housing Programs adopt the Housing First model. HMIS will host the Standard Assessment Tool, VI-SPDAT and F VI-SPDAT as part of CASA's participation in the Coordinated Entry system. Each program participant will meet with case management once a month to review financial assistance needs. A "progressive engagement" approach in case management will be used to encourage program participants to consider other, non-financial assistance options in supportive services (such as employment assistance and job training) that would sustain income levels to ensure stabilized housing after financial assistance has ended. CASA is a "Transition-in-Place" model and has been for years. The program participant will hold the lease in their name and when program participation is completed, will remain in their housing of choice. The Tucson Pima Collaboration to end Homelessness, the local Continuum of Care, contracted with OrgCode Consulting to produce a complete Gaps Analysis of housing and services this summer. One of the findings of the gaps analysis was that "For the past six years, transitional housing has been under-utilized. This trend is compelling in that the community has considerably more transitional housing that it needs, and the conversion of transitional housing to other forms of support are long over-due." The CASA program was recently reclassified as Permanent Housing - Rapid Re-Housing in response to a request to HUD. CASA will take referrals from the Coordinated Entry system to ensure that the hardest to serve homeless will continue to be enrolled in permanent housing to end homelessness in our community. It is the plan of CASA to rapidly rehouse 50 eligible program participants during the course of the year.

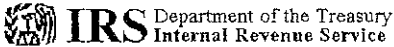




