**1. Provide a description that addresses the entire scope of the proposed project.**

The Enhanced Supported Housing Program (ESHP) is a Permanent Supported Housing Program whose goal is to house 24 of the most medically vulnerable, chronically homeless individuals and families in Pima County, where the head of the household has a disabling condition, and an active substance abuse program. ESHP targets a large subpopulation including Veterans and Non-Veterans and people living with HIV/AIDS, to obtain its primary goal of housing the most medically vulnerable families and individuals in the community. ESHP participants are not required to be sober upon entry, nor are they required to be enrolled in any treatment program or social service agency that addresses any substance abuse or psychiatric need, as determined by the Housing First Model. CODAC attempts to remove as many barriers as possible from housing members. The program accomplishes its goals first by conducting extensive outreach to shelters, other social service agencies, parks, homeless camps, and other places where the homeless congregate, using a Navigator to identify eligible participants and to help re-establish relationships between the person and formal systems. State Medicaid and CODAC housing have strengthened partnerships, to ensure timely housing referrals and tenants' access to long-term services and supports in the community. CODAC, in partnership with state agencies has SOAR trained staff to assist with developing methods for the identification, outreach, and referral of extremely low-income people with disabilities who need Permanent Housing Funded units. The initial services can range from assisting participants in obtaining required documentation and locating a unit to assisting those experiencing homelessness in alleviating their fears about reintegrating into society and re-establishing trust in the community helping networks and do not require the participant to be housed to obtain these services. Once housed, the Navigator works with the participant to rebuild their lives and provide hope for the future. The Navigator will work within the formal system and coordinate any necessary treatment with service providers, while maintaining their role in not being a decision maker. The Navigator's focus is on the needs of the participant is instrumental in helping the participant deal with any housing obstacles that may surface. Within the community, Navigators assist with reducing crime, jail sentences and unnecessary police intervention by helping the participant locate and secure housing, preventing them from committing misdemeanor crimes such as trespassing, public intoxication, panhandling, and minor thefts. Navigators also help contain the cost of medical treatment by assisting members of the homeless population in obtaining preventative medical care and obtaining health care benefits. Additionally CODAC utilizes the coordinated entry process to seek out new referrals in order

to ensure CODAC is extending services to the most medically vulnerable members.


