TPCH, in coordination with Pima County as the HMIS Lead Agency, began implementation in June, 2014, by designating the Vulnerability Index-Service Prioritization Decision Assistance Tool (VI-SPDAT) as the Coordinated Entry common assistance tool and selecting the HMIS as the software system for Coordinated Entry. Pima County staff, along with the Coordinated Entry Committee, continues to encourage participation in Coordinated Entry throughout the CoC geographic area (Pima County) and including school liasons, Headstart, hospitals, community health centers, etc. This project provides funding to support the operation of the TPCH fully implemented coordinated entry system.
