This is the primary funding for the Pima County Homeless Management Information System (HMIS) which was established in 2008. HMIS continues to expand agencies, users and programs, including the local Veterans Administration and Regional Behavioral Health Authority. The system currently supports 270 users from 35 agencies entering data into 250 programs, including coordinated entry. The project is currently focusing on System Performance Reports to the CoC, along with closely monitoring data to ensure all reports accurately report homeless services in our community. All Emergency Solutions Grant projects are participating in HMIS, as well as all CoC programs, VA funded programs such as SSVF and GPD, and the PATH project. In addition, there are a number of faith-based organization who continue to utilize HMIS as their data platform and contribute data to our system. Our HMIS has a well rounded portfolio of housing programs and supportive services, such as outreach and case management regularly entering data. Our system expanded data sharing on July 1, 2016, to include all HUD data elements and all eligible projects. HMIS training is offered multiple times each month and individual program support is provided regularly to ensure all HMIS participating agencies and users are accessing the most current workflows. Data Quality reports are monthly at the HMIS Committee, which is a required committee for all HMIS Participating agencies. The Pima County HMIS supports the coordinated entry system, including the most current versions of the VI-SPDAT, the F VI-SPDAT, the TAY VI-SPDAT and the full case management tools, referrals made to projects directly in HMIS, and ByName List data.
