3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Research consistently finds that homeless youth experience significantly elevated rates of victimization, mental health disabilities, substance abuse, sexually transmitted diseases, chronic illness, and suicide compared to their peers with stable housing. 46% percent of homeless youth have been physically or sexually abused. LGBTQ youth comprise up to 40% of homeless youth and are 7 times more likely to be victims of violent crime than their heterosexual peers. Homes First provides 16 PSH beds for highest-risk youth, offering permanent escape from homelessness and victimization.

Homes First is a Housing First program that moves chronically homeless youth ages 18-24 who are single, partnered, and/or parenting into permanent supportive housing in a best-practice scattered site setting. Once HUD eligibility is established, participants are moved into apartments in the community and provided the supports they need to stabilize. OFS leases apartments from independent property management companies and assumes all financial obligations for monthly rentals. Homes First accepts 100% of its referrals directly through Pima County Coordinated Entry and 100% of dedicated for chronically homeless youth (8 units) or youth who otherwise meet the Dedicated Plus eligibility requirements (8 units). OFS does not impose program eligibility requirements based on income levels, current/past substance abuse, criminal records (unless federal, state and/or dictates otherwise), history of DV, etc.

The program uses a client-centered case management approach. Staff are trained in Trauma-informed Care, Harm Reduction, Positive Youth Development and LGBTQ issues. Youth are involved in creating their individualized service plans. Case Managers help them identify their strengths and design realistic action plans to achieve their social, educational and employment goals. Youth choose an apartment close to support networks like school, work and family. Life skills, therapeutic counseling and educational planning are provided in-house. Case managers coordinate with and refer to partners within a comprehensive community network for needed services the program does not offer, such as HIV/Hepatitis C testing, substance abuse counseling, psychiatric and medical/dental care, and public benefits like TANF, SNAP, and Medicaid. Youth are never discharged to the streets; Our Family works to connect them to other services and housing programs if they choose to leave the program.

C. FIXED RATES:

If a fixed rate is in this Agreement, it is based on an estimate of the costs for the period covered by the rate. When the actual costs for this period are determined, an adjustment will be made to a rate of a future year(s) to compensate for the difference between the costs used to establish the fixed rate and actual costs.

D. USE BY OTHER FEDERAL AGENCIES:

The rates in this Agreement were approved in accordance with the authority in Title 2 of the Code of Federal Regulations, Part 200 (2 CFR 200), and should be applied to grants, contracts and other agreements covered by 2 CFR 200, subject to any limitations in A above. The organization may provide copies of the Agreement to other Federal Agencies to give them early notification of the Agreement.

E. OTHER:

If any Federal contract, grant or other agreement is reimbursing indirect costs by a means other than the approved rate(s) in this Agreement, the organization should (1) credit such costs to the affected programs, and (2) apply the approved rate(s) to the appropriate base to identify the proper amount of indirect costs allocable to these programs.

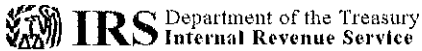


