La Casita budgeted eight vocational training slots for the one year renewal period. Only one program participant was able to complete High School/GED in order to move to a higher level of job training or job-driven certification status. La Casita will have a higher participation rate in the coming year when time limits are placed on the length of time in obtaining a High School diploma and/or GED.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

La Casita is a collaboration between the Pima County Sullivan Jackson Employment Center and the Tucson Preparatory School Inc.(Partner agency) to address a high priority gap in housing and supportive services to Tucson's homeless, unaccompanied youth and parenting young adults. La Casita will focus on skill development in four areas-educational, vocational, social, and personal living- providing program participants with an individualized and integrated program of transitional housing, education, employment assistance and job training, intensive case management, life skills training and a comprehensive support system. The target population for La Casita consist of homeless, unaccompanied youth and parenting adults between the ages of 18 to 24 years of age. The focus of the program will be placed upon youth who need to complete their education, either through GED, High School, or Charter School. The La Casita Project is participating in the CoC Coordinated Assessment System and is utilizing the VI SPDAT Assessment Tool for intakes and referrals. With few exceptions, La Casita participants will require a complete vocational assessment, employment assistance, transitional housing placement and a full range of supportive services in order to successfully enter the workforce and sustain an independent lifestyle. La Casita started serving Tucson's youth in the year 2000 and the design of the program won a HUD National Best Practice Award in August, 2000. The program intends to serve approximately 25 youth and achieve a job placement rate of 42% at program exit. The average wage at job placement outcome measurement is expected to be \$10.00/hour with a job retention and housing stability rate at 82% at program exit. La Casita will continue to enter every program participant into the Continuum's HMIS system. The Pima County Sullivan Jackson Employment Center is a satellite American Job Center dedicated to providing a full array of employment services to the homeless of the City of Tucson and Pima County. All American Job Centers are affiliated with the programs of the Workforce Innovation and Opportunities Act(WIOA) and are governed by their policy's and procedures. All participants in the programs of the Sullivan Jackson Employment Center are subsequently enrolled in the programs of the Workforce Innovation and Opportunities Act and other mainstream Dept. of Labor employment programs.

In addition, Tucson Prep estimates that Basic Equalization from the Arizona Department of Education for La Casita participants will exceed the match figure assigned to this project. Consequently, Tucson Prep commits an additional \$30,000 in leveraged funds as a parallel pledge for the above-captioned project.
