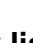

1. Provide a description that addresses the entire scope of the proposed project.

LifeWorks staff will conduct outreach to seek out and provide housing to chronically homeless individuals, couples, and families with disabilities (using the Housing First model and Coordinated Entry) and additional barriers (such as substance abuse, mental illness, and criminal history) to obtaining housing on their own.

The program will be accessible to those with disabilities, by ensuring that the primary staff office and all rental units comply with ADA. The program will be accessible to those who are deaf and/or hard of hearing by having access to an ASL interpreter. The program also offers large-print copies of forms to program participants. Additionally, the program will be accessible to those who do not speak English by having access to an interpretation phone, which connects program participants to specially-skilled translators in 30 different languages. Staff will also be sensitive to cultural needs of the program participants.

Staff will assist program participants in applying for entitlement benefits (such as SSDI, SSI, and Medicaid) and other supportive services (such as mental health, substance abuse, education, legal, medical, preventive care, disease management and employment readiness). Staff will offer a variety of individually-tailored and group interventions focusing on self-management, locus of control, symptom management, coping skills, trigger identification, contingency planning, meaningful activities, transportation, food, furniture, relapse prevention, medication management, personal enrichment, community involvement, peer support, networking, stress management, healthy boundaries, changing behaviors, and other daily living skills.

By providing permanent supportive housing, LifeWorks is a stabilizing force in the lives of chronically homeless and disabled persons. This stabilization allows program participants to end their cycle of homelessness, and improve the long-term outcomes of their lives.

The tax exemption does **not** apply to: transportation (towing), telecommunications, amusements, manufactured buildings, transient rental, or contracting. This exemption does **not** apply to purchases for personal use by anyone associated with your organization.

The City of Tucson and State of Arizona do **not** issue a "Tax Exempt Number". Your suppliers can deduct the sale amount under "Exempt Hospital" on their state tax forms for the City of Tucson using the TU location code as long as they are licensed under one of the eight activities stated above. Suppliers should call the city Audit Section at 791-4681 from 7:30 a.m. until 5:00 p.m. Monday through Friday for any verification necessary.

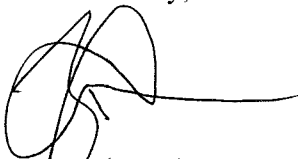
