3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Long Term Housing project operates under a Housing First model and provides case management and permanent supportive housing for people living with HIV/AIDS and their household members. The Long Term Housing project is located at an apartment complex owned by SAAF in midtown Tucson. The project includes 12 clustered project-based apartments serving 12 households without children. The 2018 renewal application will be for the 16th year of the project, and the contract year is from April 1 through March 31. SAAF housing programs has a high fidelity to the Housing First model. SAAF prioritizes literally homeless persons who are chronically homeless to receive permanent supportive housing through this project. We utilize the VI-SPDAT with all clients seeking housing to determine who is at the highest risk. The highest scoring clients are prioritized and placed into housing. SAAF does not require any preconditions for housing entry such as sobriety, drug testing, adherence to mental health/medical treatment, or substance use treatment. This allows persons most vulnerable and at risk and persons who use survival strategies like alcohol and drugs to be able to cope with life on the streets to access housing without these barriers. We do not have requirements that persons be clean or sober while in our housing. We work to support clients towards an eventual goal of recovery as determined by the client and support clients through relapse. Case management and support services are provided by SAAF staff members and volunteers to assist recipients in maintaining stable housing and accessing health care and other resources necessary for managing the effects of living with HIV/AIDS. Supportive Services matching funds are provided through Ryan White Program Part B funds. Clients in housing work with case managers to help support them and ensure that they remain in housing. If issues in a particular unit cannot be resolved we make every effort to move the client to another SAAF housing unit (through other funding sources) so they do not relapse into homelessness. SAAF offers other supportive services if desired by clients to help stabilize them and integrate them into the community including paying for therapy services, transportation, linkages to medical care, and assistance with food. This supportive structure works to retain even high risk clients in housing so they do not return to homelessness. SAAF expects the following outcomes for the program: 1) 83% of participants age 18 and older will maintain or increase their total income as of the end of the operating year or program exit; 2) 67% of participants will remain in permanent housing as of the end of the operating year or exit to permanent housing during the operating year; 3) 75% of participants will increase or maintain self-sufficiency as measured by the self-sufficiency matrix which measures accomplishments and is used to set goals for 21 factors that support housing stability.
