1. Provide a description that addresses the entire scope of the proposed project.

The Pima County One Stop Rapid Rehousing Project will target individuals with behavioral health problems, including substance additions and mental illness, and families in which one or more members have behavioral health issues. Clients will be referred to the project through the Coordinated Entry system using the VI-SPDAT mid-range score to align with Rapid Rehousing as the best housing intervention. The project will utilize a Housing First approach, in which housing is offered to people experiencing homelessness without preconditions (such as sobriety, mental health treatment, or minimum income threshold) or service participation requirements, and for which rapid placement and stabilization in permanent housing are the primary goals. The project will utilize a "progressive engagement" approach to develop client-centered case plans to address client's needs. For example a homeless job seeker may be placed for a short-term stay in shelter, and then assisted to move into permanent housing. Meanwhile, the program participant will focus on an initial employment goal; after stabilizing the household through employment, the program participant will work on developing next career move(s) and set education goals. Sullivan Jackson Employment Center will provide expert employment assistance to help project participants locate employment, increase their employment income and maximize their ability to live independently.
