3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Positive Housing Opportunities II follows a Housing First model to provide permanent supportive housing to persons experiencing homelessness who are literally homeless and living with HIV/AIDS. The project provides rental assistance to clients so they can obtain their own homes for lease in the community. SAAF administers the housing assistance and assists clients through SAAF's case management and support services. The project includes 6 scattered site units serving 6 households at any point in time. The 2018 renewal application for funding will be for the 14th year of the project, and the contract year is from October 1 through September 30.

SAAF programs have a high fidelity to the Housing First model. SAAF prioritizes persons who are chronically homeless to receive permanent supportive housing through this project. We utilize the VI-SPDAT with all clients seeking housing to determine who is at the highest risk. The highest scoring clients are prioritized and placed into housing first. SAAF does not require any preconditions for housing entry such as sobriety, drug testing, adherence to mental health/medical treatment, or substance use treatment. This allows persons most at risk who use survival strategies like alcohol and drugs to be able to cope with life on the streets to access housing without these barriers. We do not have requirements that persons be clean or sober while in our housing.

Comprehensive case management and a continuum of support services are provided by SAAF staff members and volunteers to assist recipients in maintaining stable housing and accessing health care and other resources necessary for managing the effects of living with HIV/AIDS. All clients in housing are provided the opportunity to work with case managers to help support them and ensure that they remain in housing. If issues in a particular unit cannot be resolved we make every effort to move the client to another SAAF housing unit (through other funding sources) or to a different apartment so they do not relapse into homelessness.

SAAF expects the following outcomes for the program: 1) 83% of participants age 18 and older will maintain or increase their total income as of the end of the operating year or program exit; 2) 83% of participants will remain in permanent housing as of the end of the operating year or exit to permanent housing during the operating year.

3C. Dedicated Plus

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.

A renewal project where 100 percent of the beds are dedicated in their current grant as described in NOFA Section III.A.3.b. must either become DedicatedPLUS or remain 100% Dedicated. If a renewal project currently has 100 percent of its beds dedicated to chronically homeless individuals and families and elects to become a DedicatedPLUS project, the project will be required to adhere to all fair housing requirements at 24 CFR 578.93.
