The Shelter Plus Care Partnership (SPC II) will provide 88 DedicatedPLUS units of permanent housing in conjunction with support services. The target population is individuals and families who meet the chronically homeless definition and households with the highest levels of need and vulnerabilities that do not currently meet the eligibility of chronic homelessness at time of entry. This includes persons with serious mental illness, addictions to alcohol and/or drugs, persons with an AIDS diagnosis or HIV related disease and physical and developmental disabilities. The three sub recipient agencies are Community Partnership of Southern Arizona (CPSA), Community Bridges, Inc. (CBI) and Southern Arizona AIDS Foundation (SAAF). SAAF provides services specifically addressing the needs of LGBTQ individuals and families. The sub recipients have designated staff that conducts outreach to inclusively provide services for individuals with disabilities and ensure meaningful access to services, programs and activities. Agencies participate in the HMIS and Coordinated Entry system for our Continuum of Care. Outreach workers and Case Managers assess the level of vulnerability of homeless persons using the VI-SPDAT and the FSPDAT tool. Case Managers request the name of the next chronically person ensuring that the person or family with the highest level of vulnerability is served and given the next vacancy without preconditions. Agencies have implemented the Housing First model. Wrap around supportive services are provided through leveraging and matching funds. Client centered service methods are adopted, ensuring that participants are offered access to services they choose. Program participants are not required to participate in services. Services include behavioral health services, vocational rehabilitation, case management, medications, bus passes, acquiring mainstream services such as food/nutrition, household items, SSI or veterans benefits (SOAR) and substance abuse treatment. Agencies have a designated staff member(s) who ensures that children are enrolled in school and connected to early childhood programs. Agencies assist clients in obtaining reasonably priced units in the community, and maximize rental assistance funds. All units are inspected for HUD HQS prior to a client entering the program and at least annually. The units are all scattered sites. Our PHA has begun the move on strategy and our agencies are identifying clients residing in the SPC II program who are no longer in need of supportive services and are able to “move on” to housing supported through our PHA. Agencies have housed 11 households through the HPP program with the PHA this grant year. This has increased the number of beds available in permanent supportive housing in our Continuum which frees up more units for chronically homeless persons on our Coordinated Entry list.






